## RABINDRA BHARATI UNIVERSITY KOLKATA EXCERPT OF THE REGULATION

Rules for Post-Publication Review of Answer Paper of M.A. Part-I / Part-II Examination under the Faculty of Arts. (Approved by the E.C. on 04.08.1999 on the recommendation of the Faculty Council in Arts dated 31.05.1999.)

A candidate for M.A. Part-I / Part-II Examination may apply for Post-Publication Review of his/her answer scripts within 30 days from the date of commencement of the issue of mark-sheet, in the prescribed form, with a non-refundable fee of Rs. 100/- per half paper or Rs. 200/- per full paper subject to the following conditions:

- I. Application of Post-Publication Review of answer script would be restricted to theoretical papers only and no application for the same in any Practical/Oral/Project/Dissertation paper would be entertained.
- II. A condidate may apply for review of not more that <a href="three-half-papers">three full papers</a> (for ENVS/MSW) at the said examination provided he/she has secured at least 40% of the total marks of the remaining half papers or full papers of M.A. Part-I/Part-II
- III. Original & Xerox copy of M.A. Part-I / Part-II Mark Sheet, Admit Card, Enrolment & Registration certificate to be produced at the time of checking of Review form.
